

2022-23 CHW Scholarship Fund Instructions

How To Apply:

Complete lines 1-10 on the application form as follows:

- 1-4. Enter the information requested regarding the applicant.
5. Enter your email address.
6. Enter the month and year you will, or did, begin postsecondary education and the name of the institution, if known. Please note: scholarships are not available for graduate programs.
- 7-9. Enter the information requested regarding the legal guardian or parent of applicant, if applicable.
10. Sign and date.

Required Supporting Material:

- Each applicant is to provide a written “statement of background and goals” not to exceed 500 words. Your writing should touch on your personal experience living in the affordable housing development* including thoughtful suggestions and ideas for enhancing the overall community environment of your housing development. In addition, please address your goals for the future.
- Include at least one letter of recommendation preferably from teachers, coaches, mentors, or others you have worked with closely. This letter of recommendation must specifically reference the CHW Scholarship Fund (no form letters).
- Academic transcripts are mandatory (exemption: if graduation occurred 15+ years prior, transcript is not required).
- All required materials must be submitted in one packet; partial submissions will not be considered.

Applications and supporting documentation must be received by December 31, 2022.

Please note: Failure to provide complete or legible documentation could result in a delay in the determination of eligibility for this scholarship. Scholarship awards are to be used for educational expenses (i.e. tuition, books) only, award funds will only be remitted directly to an educational institution and recipients must maintain a student in good standing status. Use of award funds will expire 2 years from the date the CHW Scholarship was awarded. Receipt of other grants and scholarships may reduce the CHW Scholarship award if the total of all aid received is greater than the student’s cost of attendance.
